I. Call to Order- Chair Mark Moore called the meeting to order at 7:00AM

A. BPA – Yakima Tributary Access & Habitat Project

1. Ellensburg Water Company/Coleman Creek Project – Anna reported to the Board that POW Contracting called last week and indicated they would be getting a retainage bond. It was received on Monday. The retainage amount due to POW is \$48,263.44 and with the bond in place, the actual funds can be released to POW. There were two formal claims submitted on the retainage funds, one from Consolidated Supply and the other from Ellensburg Cement Products. Ellensburg Cement Products submitted a release of their claim last week indicating they had been paid. The remaining claim is tied to the dispute between POW and Consolidated Supply. Anna reported that POW has filed suit against Consolidated Supply for breach of contract. It could be an extended period of time before there is resolution of the dispute between the two. In the meantime, the notice of completion form that must be submitted to the state, however the Department of Labor and Industries will not accept the form until all sub-contractors have submitted their affidavits of prevailing wages paid and the original welder has not done so.

MOTION – Accept the retainage bond in the amount of \$48,263.44 from POW Contracting and approve payment in the amount of \$48,263.44 to POW.

2. Naneum Creek –Anna presented a task order with a cost of \$3,125 from Reiss-Landreau for cultural resources survey and report on the Valley Land Company Project on Naneum Creek. The cultural resources consultation has been completed on Coleman but not on Naneum. In addition, Anna presented to the Board task order 06 for Anderson Perry in the amount of \$8,060 in order to revise the drawings for the river screen and to finalize plans to remove diversions.
