## V. Project Reports

#### A. NRCS Programs

1. District Conservationist Report – None provided.

- **B.** Annual Financial Report- Anna reported the 2023 Annual Financial Report was submitted to the State Auditor's office before the deadline.
- C. Annual Plan of Work Anna reported the Annual Plan of Work was submitted to the Conservation Commission on time. The final version is available on the KCCD website.
- D. Professional Engineering Grant The Conservation Commission approved the purchase of a new PE vehicle. Anna is working on finalizing paperwork with Kellehers as they were able to locate a regular cab Ford F150 that fit the District's needs and is under the state contract amount.
- E. 3149 RCPP Program Agreement Anna reported the agreement for this RCPP project has been signed and is active. The next step is to negotiate and sign the supplemental agreements for technical assistance and the irrigation water management entities projects.
- F. KFACC Evacuation Flyer Anna reported the evacuation flyer is completed and is currently with the Northern Kittitas County Tribune for printing and mailing. The plan is to print 15,000 English versions, mail out 13,120 of those, and keep the rest for handouts at community events and locations. Anna reported there are also 500 copies of a Spanish version. The mailing will be done by the Tribune and may need to occur in batches, taking separate checks or use of the credit card.

#### VI. Action Items

## A. Emergency Declaration - Drought

1. Anna reported the drought situation continues to worsen. A drought declaration by the state occurred in 2023 and was reissued in April 2024. KRD has declared an emergency as well. An emergency declaration by KCCD helps to justify actions taken in response to the situation, particularly involving funding and quick action.

## B. Natural Resource Investments (24-28-NR)

1. Small Project Cost Share - Review of Applications

There are eight small project cost share applications that were submitted for this program. The combined applications request \$42,633 in cost share over the course of their projects.

## 2. Cascade Irrigation District - Cost Share Agreement

Cascade Irrigation District has encountered a catastrophic failure of equipment involved with their pump station. They are unable to deliver water to a significant portion of the users while repairs/upgrades are underway. This is a very difficult situation with impacts to agricultural producers on top of the drought conditions and the expected impacts through the summer. CID approached Anna asking for any potential financial assistance. The NRI grant has funding not committed due to the number of Small Project Cost Share applications received. Anna is working with the Conservation Commission to ensure that assistance to CID is eligible for this funding.

## C. Manastash Compressors

1. The Manastash Compressor Replacement Project is advertised currently with bids due Monday June 24. The estimated project cost is \$35,000 to \$40,000. Due to the long lead time for the compressors, it's important to move quickly after the bids are received.

## D. 24-28-SFF Sustainable Farms & Fields

1. Addendum- KCCD submitted an application for a compost spreader and screening equipment for Green Bow Farm for \$30,000. The Commission awarded those funds in May.

## 2. Green Bow Cost Share Agreement

Green Bow is the applicant that requested KCCD apply for the Sustainable Farms & Fields money. They are requesting help with a composting project within the Sustainable Farms & Fields guidelines.

As a result of that contact, Tony began talking to them about their community owned lands along 903, a high priority for the CWDG work. Approximately 4 acres will be treated. This is adjacent to USFS parcels that are also being treated.
